- Terms and Conditions -

- 1) **CREDIT APPROVAL:** This trade account will be subject to the credit policies of Bartle & Gibson Co. Ltd. and the provisions contained in this application unless otherwise agreed in writing. Orders are accepted subject to satisfactory credit approval. Pending approval, delivery may be delayed without liability to Bartle & Gibson Co. Ltd. All clerical errors are subject to corrections.
- 2) **TERMS:** Unless otherwise stated, terms of payment are net 30 days from the end of the month. Purchases on account during the month are to be paid on, or before, the end of the month following.
- 3) **LEGAL COSTS:** The Customer shall be responsible for all legal costs on a solicitor and client basis, incurred with respect to collection on all past due accounts.
- 4) **SERVICE CHARGES:** Interest shall be charged on all past due accounts, including legal costs, at the rate of **2 per cent per month (24 percent per annum)**.
- 5) **RETURNED GOODS:** Written permission must be obtained from Bartle & Gibson Co. Ltd. before returning any goods for any reason. The original invoice number on which the goods were purchased must be supplied. Goods returned for credit will be subject to a restocking charge of 25% of the invoice value of the goods plus reconditioning costs if required. All returned goods must have transportation charges prepaid. Products which are obsolete, used or built-to-order are not returnable.
- 6) **CLAIMS:** No claims may be made that the goods received are damaged or not in accordance with the order placed unless made in writing and received by Bartle & Gibson Co. Ltd. **within 10 days after the said goods are delivered.** Bartle & Gibson Co. Ltd. will not be liable for any failure to meet delivery dates occasioned directly, or indirectly, by strikes, fire, flood, riot, war, labour stoppage, walkout, lack of transportation, shortage of raw materials or supplies, government regulations, or any other cause beyond the control of Bartle & Gibson Co. Ltd. Written notification of any invoice error must be made within 60 days from the date of the invoice.
- 7) **CANCELLATION:** Orders accepted by Bartle & Gibson Co. Ltd. for special material not normally stocked are not subject to cancellation or to change except with the consent of Bartle & Gibson Co. Ltd., and upon terms which will indemnify Bartle & Gibson Co. Ltd. against consequential loss or damage.
- 8) **PRODUCT WARRANTY:** Will be covered by and subject to the warranty policy of the manufacturer.
- 9) **PRICES:** Subject to change without notice. Orders are invoiced at prices in effect at the time of shipment.
- 10) **F.O.B.:** Bartle & Gibson Co. Ltd. warehouse.
- 11) **ALL TAXES EXTRA.**
- 12) **DELIVERY CHARGES:** Delivery charges will be applied to **ALL** delivered orders excluding backorders.
- 13) **BUSINESS CHANGES:** Any changes regarding business structure, ownership, or incorporation must be made to Bartle & Gibson Co. Ltd. in writing. Until such time as the new account is approved for credit, the applicant accepts responsibility for purchases on this account.

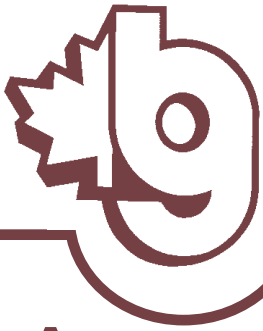
